Funda Wazi means "learn and know" in Zulu language. It is a non-profit, non-governmental and registered as an Incorporated Trustee in Nigeria. The Mission is to provide a child-friendly environment for learning, promote educational development and provide relevant resources that will assist children and adults to learn and know how to address social challenges affecting children.

At Funda Wazi, we channel our efforts on prevention and mitigating children from abuse, neglect and other forms of violence in schools, homes and the community at as we believe the first approach to ending child abuse is to prevent the cycle of child abuse from continuing.

Established by Mrs. Nomthi Odukoya; a seasoned educator and Life Coach with a passion for working with children, parents and teachers to prevent, mitigate and respond to the sad systemic social ills that affect children in the society. The Foundation works with various stakeholders' such as families, state government, teachers, educators and communities to provide long-term education and also ensure that children are well equipped to cope with childhood and social ills occurring in the environment.

### Coordinator's report



From the onset I will like to thank our founder, funders, partners and volunteers for their support and guidance in our mission to develop child-friendly and relevant resources and tools that will assist children and adults to "learn and know" how to address the social challenges affecting children.

The year 2016 heralded the beginning of the Foundation's quest to achieving its mission as our activities has directly impacted over hundreds of children in the community around us and in Nigeria as a whole. We have recorded modest achievements this year and would like to share key highlights of those events that have significantly impacted our beneficiaries

and the community at large.

The organisation of Project F.A.P.E (Funda Wazi Arts and Poem Writing Event). A competition opened to private and public primary schools in Lagos state. This event was put together to raise awareness and address issues concerning the rights and well-being of children in our country, the theme of the competition was "A Bully is not a Hero". Children were required to submit a poem of 4 stanzas of 200 words. The Arts competition involved creative and Imaginative drawings depicting the same theme. The Winning schools and students were recognized and awarded with gift rewards which was announced and publicized at the event which was held on the 27th May 2016 at ilupeju in commemoration of the Children's day celebration.

Other keys event that occurred during the year was the Book and Literacy day; a 2 day program which took place across public schools located in the less privileged area of Lagos State. At the program free books, stationaries and notebooks are classified, sorted and distributed by the age group for which they are intended to benefit. The Program took place in public schools in Amukoko and Makoko slum areas of Lagos State. Over 800 copies of child friendly and interactive books that teaches children how to learn and know how to address social challenges affecting them were distributed.

In addition, the Foundation in its bid to support many underprivileged children who wish to learn to read and write, but cannot afford it, solicited the public fairly used educational books, educational materials including novels, text books, stationaries, story books, poems and rhymes etc. The Project "Donate don't dump" was carried out in December 2016. Our Goal was to empower 500 young children in public primary schools in Lagos state to read hereby offering them a lifetime gift of literacy.
