In 2017, Funda Wazi Foundation reached out to over 5,000 children across 50 schools in Lagos State. This was a realization of my dream and passion of working with children, parents and teachers to prevent, mitigate and respond to the sad systemic social ills that affect children in our society. Child abuse and neglect are particularly important because they are often directly associated with adverse physical and mental health consequences in children and families.

Within the past year, the Foundation has distributed thousands of books to children across Nigeria and particularly worked with schools in communities where resources are scarce. We have organised seminars and children's competition where

#### BRIEF DESCRIPTION OF THE FOUNDATION

Funda Wazi means "learn and know" in Zulu language. It is a non-profit, non-governmental and registered as an Incorporated Trustee in Nigeria. The Mission is to provide a child-friendly environment for learning, promote educational development and provide relevant resources that will assist children and adults to learn and know how to address social challenges affecting children.

At Funda Wazi, we channel our efforts on prevention and mitigating children from abuse, neglect and other forms of violence in schools, homes and the community at as we believe the first approach to ending child abuse is to prevent the cycle of child abuse from continuing.

Established by Mrs. Nomthi Odukoya; a seasoned educator and Life Coach with a passion for working with children, parents and teachers to prevent, mitigate and respond to the sad systemic social ills that affect children in the society. The Foundation works with various stakeholders' such as families, state government, teachers, educators and communities to provide long-term education and also ensure that children are well equipped to cope with childhood and social ills occurring in the environment.

#### FOUNDATION'S FOCUS AREAS

#### **EDUCATIONAL AND CHILD DEVELOPMENT:**

Providing resources and tools to engage children and adults to enable them understand and effectively prevent and address growing social challenges.

Organizing forums that will bring key stakeholders together to address critical issues affecting children and their education.

Carrying out empirical research on issues affecting children's social, emotional and physical wellbeing.

#### **ADVOCACY:**

Public advocacy in order to create sensitization on Child Abuse, neglect and other forms of violence with the public at large in order to create more visibility and awareness about the issue of child sexual abuse

The use print and social media as a tool for building awareness and advocating for attitudinal change towards topical issues affecting children

#### PARTNERSHIP AND COLLABORATIONS:

Building partnerships and collaborations with other NGOs, government agencies and -bilateral and multilateral organizations

Build the capacity of stakeholders to use resources to address challenges facing children

#### **OUR MAJOR PROGRAMMES**

PROJECT F.A.P.E: Funda Wazi Arts and Poem Writing Event (Project F.A.P.E) is an annual Arts and Poem writing competition opened to private and public primary schools in Lagos State, Nigeria. The aim of the competition is to enable every child have the right to express their views, feelings in all matters affecting them and to have their views considered and taken seriously. This event raises awareness and addresses issues concerning the protection and wellbeing of children generally.

**FUNDA WAZI BOOK AND LITERACY EVENT:** Funda Wazi Book and Literacy event is an evidence-based intervention proposed to address low levels of literacy among children in disadvantaged circumstances. The Book and Literacy day is a two-day program which takes place across public schools located in the less privileged area of Lagos State. At the program, free books, stationeries and notebooks are classified, sorted and distributed to the age group for which they are intended to benefit.

TEACHERS EXPLORING THROUGH MENTORSHIP (T.E.M): Teachers exploring through Mentorship (T.E.M) is a bi-annual program where professionals (mentors) from different sectors act as role models and speakers to offer advice and guidance regarding education, training, and skills for their mentees (teachers). Objectives include to support and guide teachers in their career and professional goals, create a plan towards achieving such and at the same time enhance teaching practice and child learning and development. To Increase community awareness about child abuse, neglect and other forms of violence and educate on strategies for recognising, preventing and protecting children in such situations.

#### **FUNDA WAZI ANNUAL CHRISTMAS PARTY**

This is an annual Christmas party organized by the Foundation for Public school children within the less privileged area of Lagos state. This is an avenue for the Foundation to show love to children in need and also to share the Love of Christmas abroad the hearts of this children.



#### COORDINATOR'S REPORT

As the scale of violence against children continues to increase, it is ever more important that we continuously empower children, parents and caregivers alike to create and sustain the requisite safe spaces for children. The Foundation has seen substantial growth in the number of parents, teachers and children supported in the past year.

To date, it has reached over 5,000 children across 50 schools in Lagos State. The Foundation's ability to empower children, teachers and parents with the requisite knowledge and information that they need to protect and sustain a safe environment for children as brought about transformational initiatives with remarkable testimonies. Our Founder contributes generously to these and our staff and supporters ensure their success.



The year 2017 heralded the beginning of the Foundation's quest to achieving its mission as our activities has directly impacted over hundreds of children in the community around us and in Nigeria as a whole.

Key Highlights of those events that have significantly impacted our beneficiaries were:

- Teachers Exploring Through Mentorship program an annual program where professionals act as role models, offer advice and guidance regarding education, knowledge, finance, skills and career choices for their mentees.
- A visit to Greenspring school Anthony Campus to speak to the children at the Anti- Bullying Day Celebration.
- The organisation of Project FAPE (Funda Wazi Art and Poem Event) held on the 27th of May 2017 across 20 private and public primary schools in Lagos State.
- October 2, 2017 the Foundation organised the Project ICARE (Intervention Protection and Prevention of Child Abuse). The Program provides opportunities to share knowledge and best practice on how to focus on strengthening the protection of children from abuse, neglect and other forms of violence in schools, homes and the community at large.
- Collaborative approach is a key factor behind the numbers we reach and the quality of our work. So, in 2017, the Foundation collaborated with Dreams from The Slum, an NGO operating in Ajeromi Ifelodun Local Government Area of Lagos State (Popularly known as Ajegunle) where it went to educate over 200 children (attending Low cost schools) on Awareness on Child abuse.
- Collaboration with Google Nigeria, Nigeria Film and Video Censor Board for the 2017 Safe

Internet Day Celebration. Funda Wazi enrolled 3 private secondary school for the program and was in charge of educating children (through Drama) from over 10 secondary schools on how to stay safe from harm, exposure to inappropriate material online.

 To round up the year, the Foundation hosted over 300 Children of Alafia Oluwa Primary School Mushin to a Christmas party to celebrate the yuletide season.

In summary the Funda Wazi Foundation has in the year 2017 engaged in awareness and advocacy activities that have led to positive and lasting reduction of social challenges affecting children. In furtherance of our mission we are not resting our oars in the coming year 2018 as we have a line-up of activities and projects that will promote this mission. We continue to solicit your support in reducing the menace of abuse and exploitation of children and promote proper child learning and development in the long run. As we set out to achieve our goals, we thank you as you have given us the much-needed momentum.



#### **FUNDA WAZI BOOK AND LITERACY EVENT**

Funda Wazi Book and Literacy event is an evidence-based intervention proposed to address low levels of literacy among children in disadvantaged circumstances. The Book and Literacy day is a 2-day program which takes place across public schools located in the less privileged area of Lagos State. At the program, free books (including our resources), stationeries and notebooks are classified, sorted and distributed to the age group for which they are intended to benefit. The Foundation visited Ajegunle Environment in Lagos State to raise Public awareness on child sexual abuse and distribute books to 215 students from 4 low cost private schools in the slum. The Foundation collaborated with Dreams from The Slum, an NGO operating in Ajeromi Ifelodun Local Government Area of Lagos State



## TEACHERS EXPLORING THROUGH MENTORSHIP (T.E.M)

The Foundation in its bid to support many underprivileged teachers held the first Teachers exploring through Mentorship (T.E.M) program in March 2017. It is an annual program where professionals act as role models, offer advice and guidance regarding education, knowledge, finance, skills and career choices for their mentees. At the program professionals from leading finance and educational institutions will act as role models, offer advice and guidance regarding education, knowledge, finance, skills and career choices for their mentees. The Event was held at Ilupeju Lagos with a total of 53 Participants from across 7 private schools, 3 public schools and 5 individuals in the teaching profession in Lagos state. The Mentors at the program were: Mrs Nomthi Odukoya( Founder Funda Wazi Foundation ), Mr. Olakunle Soriyan(Total Life Management Coach), Barrister Taiwo Akinlanmi (Lawyer ,Child Rights Activist and Social Empowerment Advocate ) with Mrs. Lai Koiki (the Founder and Executive Director Greensprings School Lagos) , Mrs. Olufunto Igun (Chief Executive Officer of Corona Schools Trust Council ) and Mr. Muktar Mohammed (A Financial Analyst and Stock broker) as the Mentors who gave great and refreshing word of advice to teachers



## THE PROJECT C.A.R.E (CHILD ABUSE PREVENTION-THE ROLE OF EDUCATORS)

The Bi Annual T.E.M program held its second edition in October 2017 titled Project C.A.R.E (Child Abuse Prevention-the Role of Educators). A 1-day workshop and training program for teachers with a focus on the dissemination of information on child protection best practices. It is a program intended to offer examples of successful initiatives undertaken by civil society organizations as well as individuals and government agencies concerned with protecting children around the world from abuse, neglect and other forms of violence in schools, homes and the community at large.





#### FUNDA WAZI ANNUAL CHRISTMAS PARTY

This is an annual Christmas party organized by the Foundation for Public school children within the less privileged area of Lagos state. This is an avenue for the Foundation to show love to children in need and also to share the Love of Christmas abroad the hearts of the children. In December 8,2017 The Foundation visited Alafia Oluwa Public School Mushin Lagos, showering 300 students with gift and love and used the opportunity to raise awareness on child abuse and also teach children how to protect and prevent themselves from child abuse.






